Assignment of Intellectual Property

1. Seller Warranty

Seller hereby warrants that he is not previously assigned, transferred, or hypothecated any item described herein.

2. Fee

For the "Assignment of Intellectual Property" defined hereafter, Josef Dolezal [Buyer] shall pay the Jordan Maxwell [Seller] the sum of One U.S. Dollar [\$1.00] & other valuable consideration, the receipt & adequacy of which is hereby acknowledged.

3. Assignment of Rights

For valuable consideration (as set forth above), Seller assigns to Buyer all the Seller's right, title, and interest in any and all Intellectual Property including but not limited to copyrights, patents, trademarks, service marks, trade secrets, domain names, [www.jordanmaxwell.com, www.jordanmaxwell.org, www.jordanmaxwell.net, www.jordanmaxwell.info], and other related proprietary rights (the Intellectual Property) now owned or hereafter claimed by Seller.

4. Scope of Transferred Rights

For any trademark or service mark rights that are being assigned, Seller also transfers to Buyer any goodwill associated with such marks.

5. Additional Documents
